1. Letter addressed to AIPEX's Chairman;

2. Form and Cover Sheet, duly filled in, signed by the applicant or beneficiary (to be acquired at the SME Post);

3. Proof of Payment of the Migratory Act;

4. Criminal Record Certificate of the origin or habitual residence, translated into Portuguese duly recognized by the Consular Services;

5. Medical certificate, from the country of origin or habitual residence translated into Portuguese and duly recognized by the Consular Services;

6. Photocopy of the passport, of the main pages and the ones containing information on migratory movement;

7. Three recent, identical photographs, in color with white background;

8. Power of Attorney or Deliberative Act in favor of the person representing the investor in Angola, if applicable.

9. Proof of investment registration issued by the entity responsible for private investment (CRIP);

2. Form and Cover Sheet, duly filled in, signed by the applicant or beneficiary (to be acquired at the SME Post);

3. Three recent, identical photographs, in color with white background;

4. Proof of payment of the Migratory Act;

5. Work contract or contract – the promise of work;

6. Certificate of academic and professional qualifications, translated into Portuguese and duly authenticated by the Consular Services

7. Curriculum Vitae translated into Portuguese and duly authenticated by the Consular Services;

8. Criminal record certificate and medical certificate issued by the authorities of the country of habitual residence or origin, translated into Portuguese and duly authenticated by the Consular Services;

9. Opinion of the Ministry of Tutelage of the activity;

10. Photocopy of the Official State Gazette and the company's Economic Activity License;

11. Updated proof of payment of tax obligations;

12. Proof of deposit of repatriation bond;



13. Declaration in which you commit to respect the Angolan laws;

14. Proof of investment registration issued by the entity responsible for private investment (CRIP).

1. Letter addressed to AIPEX's Chairman;

2. Form and cover page, duly filled in, signed by the applicant or beneficiary; (to be acquired at the SME Post);

3. Three recent, identical photographs, in color with white background;

4. Documents proving the degree of kinship (marriage certificate and birth certificate for minor children), translated into Portuguese and duly recognized by the Consular Services;

5. Proof of payment of the Migratory Act;

6. Declaration in which he/she commits to respect the Angolan laws;

7. Medical certificate and Criminal Record issued by the authorities of the country of origin translated into Portuguese and duly authenticated by the Consular Services

8. Photocopy of the passport, of the main pages and those containing information on the migratory movement and the Investor/Worker visa;

9. Proof of Investment Registration issued by the entity responsible for private investment (CRIP)

#### STAY VISA

4. Three recent, identical photographs, in color with white background;

5. Proof of payment of the Migratory Act;

6. Proof of Investment Registration issued by the entity responsible for private investment (CRIP).

By the provisions of Article 57 of Law 13/19, May 23rd Legal Regime of the Foreigner in the Republic of Angola, combined with Articles 53 and 54 of Presidential Decree 163/20, June 8th Regulation on the Legal Regime of the Foreigner in the Republic of Angola.

- 1. Letter addressed to AIPEX's Chairman;
- 2. Form and Cover Sheet, duly filled in, signed by the applicant or beneficiary;
- 3. Proof of payment of the Migratory Act;

4. Copy of the passport on the main pages and those containing migratory movement information;

5. Three recent, identical photographs, color passport type, and white background;

6. 0. Up-to-date Criminal Record Certificate and Medical Certificate issued by the Angolan authorities;

7. Proof of Investment Registration issued by the entity responsible for private investment (CRIP).

OBS: a temporary residence permit can be granted to an investor holding an investor visa, with 3 years of uninterrupted stay in the national territory.
